

This refers to this Office's Memorandum, dated 20 May 2019, directing all department secretaries and heads of agencies, GOCCs and GFIs to refrain from issuing travel authorities for official foreign trips to Canada, and to reduce official interaction with representatives of the Canadian Government.

In view of the Canadian Government's retrieval and reshipment to Canada of the containers of garbage mentioned in the aforesaid directive, please be informed that such directive is hereby LIFTED, effective immediately.
