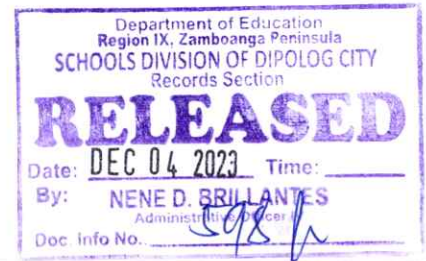

4. Anent this, each school is enjoined to send one (1) Learner Rights and Protection Focal Person (formerly known as Child Protection) to enroll in the said e-learning course.
