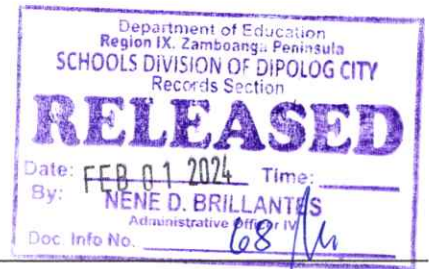

1. Pursuant to the issuance of Regional Memorandum No. 040, s. 2024 dated January 17, 2024 requiring all elementary and secondary schools to conduct classroom-based learning sessions on Anti-Online Sexual Abuse and Exploitation of Children (OSAEC) and Anti-Child Sexual Abuse or Exploitation Materials (CSAEM) in compliance with Presidential Proclamation No. 417 “Declaring the Second Tuesday of February of Every Year as Safer Internet Day for Children in the Philippines and in line with the promulgation of the Implementing Rules and Regulation (IRR) of RA No. 11930.
2. These classroom-based sessions with presentation decks and accompanying guide scripts will be administered by all classroom advisers within each key stage during their Homeroom Guidance subjects which can be accessed through this link: <https://bit.ly/AntiOSAEC-CSAEMSessionGuides>.

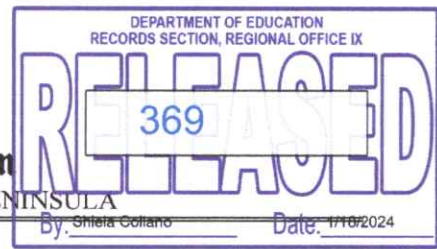

1. The Department of Education (DepEd) through the Learner Rights and Protection Office (LRPO) and the Office of the Undersecretary for Curriculum and Teaching, together with the Stairway Foundation, Inc (SFI) will conduct a classroom-based learning session that aims to increase awareness of the anti-OSAEC and CSAEM policies in schools.
2.
