The Department of Education (DepEd), through the Curriculum and Teaching Strand, will conduct the nationwide administration of the Rapid Math Assessment (RMA) and Comprehensive Rapid Literacy Assessment (CRLA) for Grades 1 to 3 and Philippine Informal Reading Inventory (Phil-IRI) Assessment for Grades 4 to 6 for the End-of-School-Year (EOSY) 2023-2024, ensuring coverage across every public elementary school in the country.

The results of these assessments shall serve as a basis for identifying grade readiness and skills requiring improvement in reading and math skills. They shall assist teachers in the design of support activities in the three (3) camps in the National Learning Camp (NLC). Additionally, the Phil-IRI shall be used to measure and describe Grades 4 to 6 learners' reading performance to assist teachers in the design of other EOSY break activities, such as remedial and enrichment classes.

The EOSY RMA, CRLA, and Phil-IRI shall be administered from April 22 to May 10, 2024. The EOSY RMA shall be administered starting April 22, 2024, while the EOSY CRLA administration shall commence on April 29, 2024.

Both the RMA and CRLA shall be administered as follows:

- 1. Grade 1 beginning-of-the-school-year (BOSY) assessment tool Part 1 for learners currently enrolled in Kindergarten;
- Grade 1 assessment tools for learners currently enrolled in Grade 1;
- 3. Grade 2 assessment tools for learners currently enrolled in Grade 2; and

Grade 3 assessment tools for learners currently enrolled in Grade 3.

The Bureau of Curriculum Development (BCD) shall conduct an orientation on the CRLA tools prior to the administration. A separate Memorandum shall be issued for this purpose.
