3. The designated chaperones shall coordinate with the Regional and Central offices for the approval and submission of the required documents. They must also facilitate in the pre-registration process of all the participants.
4. Per guidelines, the travel and personal insurance expenses of the learner-participants, along with the same items plus incidental expenses for the chaperones, will be charged to the LSP 2023 or 2024 funds, Local Funds, Maintenance and Other Operating Expenses, Local School Board – Special Education Fund, or other funding sources, subject to the usual accounting and auditing rules and regulations.
5. Accommodation, including billeting quarters and meals, is provided free of charge by the central office. **Participants from Region IX will be accommodated at Basak Elementary School** in Lapu-Lapu City, Cebu. The accommodation period will be from 7:00 a.m. on Monday, July 8, 2024, until 12:00 p.m. on Saturday, July 13. The first meal provided will be lunch on July 8, and the last meal will be breakfast and morning snacks on July 13.
6. A separate advisory will be issued in the coming days for the orientation and briefing of the participants. Meanwhile, the school heads of the selected learners will facilitate communication on behalf of the SSLG teacher-adviser.
