1. This is to announce the **12th WESTERN MINDANAO REGIONAL SCOUT JAMBOREE**, which will be held on August 23 - 26, 2024, at Kampo Pabibo, Brgy. Mawal, Leon B. Postigo, Zamboanga del Norte with the theme **“Youth Engagement: Sustaining Relevance and Strengthening Resilience.”**

2. The Jamboree aims to provide a progressive, exciting, challenging, safe, and enjoyable learning environment for the Scouts in order to enhance their full social, physical, intellectual, character, emotional, and spiritual potentials as active citizens making real contributions to creating a better community.

3. The estimated cost of participation per scout/adult leader is as follows:

4. The participants of the abovementioned activity shall be entitled to service credits, subject to the provisions stipulated under DECS Memorandum No. 143, s. 1997. Likewise, non-teaching personnel shall be provided with compensatory time off (CTO) per CSC and DBM Joint Circular No. 2, s. 2004.
