

1. In light of the recent results from the Programme for International Student Assessment (PISA) Pre-test in Science, this office continues to enhance PISA learning practices by implementing learning integration sessions in all PISA-participating schools.
2. The Curriculum Implementation Division (CID), through the Education Program Supervisors and Public Schools District Supervisor, will conduct weekly monitoring of the PISA learning intervention sessions for the identified 15-year-old learners. 3. Moreover, there will be a weekly PISA practice test every Friday during the English, Science, and Math class schedule.
