

1. The Department of Education (DepEd), through the Bureau of Education Assessment (BEA) in coordination with the Bureau of Alternative Education (BAE), announces the registration period for the administration of the **2024 Accreditation and Equivalency (A&E) Test**.
2. Pursuant to DepEd Order No. 55, s. 2016, titled *Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program*, the A&E Test aims to measure the competencies and life skills of those who have not yet attended or finished elementary and secondary education. This assessment shall allow learners to obtain the certification of completion at different levels that exists in Basic Education, which may be used to access further education, job promotion, entry to job training, and employment.




