## CLOSED-DOOR PRE-EVALUATION OF THE SEARCH FOR THE MOST OUSTANDING BATANG DIPAG CAMPUS AMBASSADORS: IDOL GROUP - P-POP DANCE CREW EDITION

In line with Division Memorandum No. 19, s. 2025 and in adherence to the Department's mandate to celebrate National Students' Day, the Batang Dipag Fest: Search for the Most Outstanding Campus Ambassadors – Idol Group: P-Pop Dance Crew Edition is set to commence its first phase. As part of the selection process, all participating groups will undergo a closed-door pre-evaluation of their contest piece performance, featuring *Wala Ng Iba* by 1st.One.

The pre-evaluation is scheduled for **Saturday, March 8, 2025, at 8:00 a.m. at the DepEd Dipolog Training Center (DTC)**, Miputak, Quezon Avenue, Dipolog City, located across Oval Pawnshop. Participants must be accompanied by their designated chaperones (dance coach or teacher). See attached **Enclosure 1 for the official list of participants**.

To ensure optimal performance, ambassadors are advised to wear comfortable activewear—costumes are not required, as it is not part of the pre-evaluation criteria. Furthermore, to ensure a smooth and organized scheduling process, each school has been assigned a **designated time slot** for its pre-evaluation session. Refer to **Enclosure 2 for the indicative schedule**.

Principals are encouraged to support participating ambassadors by covering transportation expenses and snacks, which may be sourced from any available funds allocated for youth programs, subject to standard accounting and auditing guidelines.

Coaches must submit the **signed parental consent** form on the day of the pre-evaluation. See the attached **Enclosure 3 for the template**.

Teaching and non-teaching personnel involved in this activity shall be granted a 1-day service credit or compensatory overtime credit, respectively. Attendance sheets and DTRs must be duly accomplished and submitted.

The participation of learners and non-teaching personnel is in full compliance with the policy on off-campus activities as outlined in DO 66, s. 2017.
