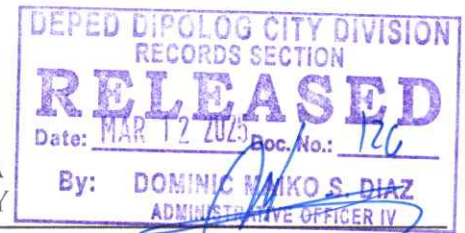

The event will now take place on **March 20, 2025, at 8:00 a.m., at the Zamboanga del Norte Convention Center Plenary Hall, Ground Floor**. In line with this, all participants are requested to arrive on time to maximize the allotted time provided by the host venue.
2. To ensure a seamless presentation, all P-Pop Dance Crew participants are required to attend the first and **final dress and technical rehearsals on March 19, 2025, at 8:00 a.m.** The rehearsals will be held at the Zamboanga del Norte National High School Covered Court, Estaka, Dipolog City. Participants **must bring their complete costumes and props** (if any) for guidelines review and checking.
