

Greetings of Peace.

The Pantawid Pamilya National Advisory Committee (NAC) Resolution No. 34 series of 2016 entitled "The Youth Development Session of Pantawid Pamilya Pilipino Program" is the Highest policy-making Inter-agency body that provides policy directions and guidance on matters pertinent to program implementation. Also, the NAC Resolution No. 13 Series of 2013, Continued Support for Children Beneficiaries of the Pantawid Pamilya Pilipino Program to finish High School, highlights the adoption of continued support to children's beneficiaries under Pantawid Pamilya by extending its program coverage to go beyond the five-years limit up to 18 years of age for them to finish High School Education.

Further, in 2016, the National Advisory Council (NAC) passed Resolution No. 34 approving the implementation of the Youth Development Session (YDS) as a school-based monthly complementary intervention for high school student beneficiaries. The YDS is complementary learning to the Family Development Session (FDS). It provides additional learning intervention to adolescent children of 4Ps households by ensuring that they are capacitated to perform supportive functions pin the achievements of the family's overall well-being. YDS aims to engage youth to become more active in learning and development and acquire knowledge, skills, and attitudes that will prepare them for adult life.

However, due to the onset of Covid-19 in 2020, the Philippine government-imposed prohibitions on face-to-face interactions and mass gatherings, including the suspension of face-to-face classes, hence the halt of the conduct of monthly YDS in school-based.

In connection with this, the Department is writing to seek your approval on the anew conduct of YDS as a school-based approach to our 4Ps monitored children. The YDS would greatly help in reducing risky behavior, removing deterrents, enhancing opportunities, and developing life skills on issues and challenges faced by the Filipino Youth which may include but are not limited to teenage pregnancy, cyberbullying, Mental Health Issues, and any others that would greatly benefit the interest of our youth.

We will highly appreciate receiving your response regarding this matter, specifically on the following:

- a. Allowing the conduct of YDS inside your school premises during weekdays;
- b. Your recommendation/suggestion in making the conduct of YDS more feasible.

Nonetheless, the YDS will be facilitated by the City/Municipal Links of the program in coordination with our Resource persons from other program partners.

Through the National Advisory Council (NAC) Resolution No. 34 approving the implementation of the Youth Development Session (YDS) as a school-based monthly complementary intervention for high school student beneficiaries. The YDS is complementary learning to the Family Development Session (FDS).

The YDS is deemed necessary to develop and enhance the life coping skills of youths, offer a positive perspective in life, and nurture their character towards individual growth and personality development. The YDS provides knowledge and teaches skills needed to support adolescents' physical, sexual, cognitive, social, and emotional development in preparation for future adult roles and responsibilities

With this, the implementation of youth development activities at the City/Municipal Level will fully resume this February 2024, all City and Municipal Operations Offices are hereby directed to ensure the following:

- Conduct of Youth Development Sessions as one of the monthly activities for the children and youth beneficiaries of Pantawid Pamilyang Pilipino Program.
- Use of YDS Modules starting from Volume 1 and other relevant modules. They may also decide on topics or activities that will be based on the group members' needs.
- The YDS may be conducted face-to-face or through other modalities as applicable in the field.
- 4. The target participants of the YDS are the 4Ps youth who are:
 - a. Students enrolled in High School both Junior and Senior High School.



- b. Students enrolled in the different Alternative Delivery Mode (ADM) of Learnings.
- c. Students that are non-compliant and not attending school (NAS).
- Prepare an Inventory of Not Attending School and conduct Community Based Youth Development Session with relevant topics that would help and encouraged them to be back in school.
- Ensure the attendance in Youth Development Session be prepared by the C/ML and reviewed by SWO III.
