

- Relative to the Joint Memorandum OM-OSEC-OUOPS-2025-01-01456 or the REITERATION OF DO 22, S.2024 ON CLASS SUSPENSION AND STRENGTHENED MONITORING AMID INCREASED HEAT INDEX LEVELS, all Regional Offices (ROs) and Schools Division Offices (SDOs) are mandated to conduct Heightened Monitoring and Granular Assessment to include the following:
 - a. Conduct continuous surveillance of local heat index and environmental conditions;
 - b. Undertake periodic assessments of school facilities;
 - c. Implement precautionary strategies;
 - d. Identify schools that necessitate the deployment of Alternative Delivery Modes (ADM);
 - e. Ensure compliance with DepEd Order No. 006, s. 2021
- 2. Thus, to facilitate evidence-based decision-making and ensure prompt institutional response, all School Heads shall submit weekly situational reports through the following:

- 3. Reports shall be **submitted every Friday by 5:00PM** to ensure timely consolidation and analysis. The following data are required in the report:
 - a. Learning Delivery Adjustments
 - i. School using SLMs
 - ii. Schools adopting hybrid learning
 - iii. Schools implementing the Dynamic Learning Program (DLP)
 - b. School Readiness and Safety Measures
 - i. Schools with proper ventilation (sufficient fans, unrestricted airflow, or airconditioning)
 - ii. Schools with functional drinking water facilities (e.g. water dispenser, water fountain)
 - iii. Schools that checked electrical wiring
 - c. Class Schedule Adjustments and Uniform Policies
 - i. Schools adopting adjusted class scheduling
 - ii. Schools allowing more comfortable alternate uniforms for learners and personnel
 - d. Health and Safety Monitoring
 - i. Reported hazards/health-related incidents among learners
 - ii. Reported hazards/ health-related incidents among personnel
