INSTITUTIONALIZATION OF THE VISION IN ACTION (VIA) PLAYBOOK: IMPLEMENTING LEARNER GOVERNMENT PROGRAMS, PROJECTS, AND **ACTIVITIES FOR SCHOOL YEAR 2025-2026**

- In pursuit of the effective implementation of the Department of Education -Bureau of Learner Support Services' Learner Government Program (LGP), this Division formally institutionalizes the Vision In Action (VIA) Playbook. The VIA Playbook is an innovative and strategic guide designed to empower the Supreme Elementary Learner Government (SELG) and the Supreme Secondary Learner Government (SSLG) in the planning, execution, and documentation of learner-led programs, projects, and activities throughout the school year.
- 2. This initiative aims to:
 - Provide a clear, structured, and gamified framework for learner government implementation in alignment with DepEd policies and contextualized division priorities;
 - · Strengthen the planning and leadership capabilities of SELG and SSLG officers through goal-driven and points-based project execution;
 - Promote learner voice, accountability, and inclusivity in co-curricular programming and student-led governance;
 - Establish transparency and consistency in documentation and reporting through standardized templates and evaluation tools (e.g., GPOA and KABILIN Reports);
 - · Recognize and reward outstanding performance through a tiered recognition system under the Orchid Ablaze Awards;
 - Encourage innovation and meaningful engagement in school communities;
 - Foster collaborative partnerships between student leaders, teacheradvisers, and school administrators to ensure aligned and sustainable implementation of the LGP.

All previous issuances, mechanisms, or practices related to the implementation of the LGP that are inconsistent or in conflict with the provisions of this Playbook are also repealed, amended, or modified accordingly.
- 5. All **SELG and SSLG teacher-advisers**, together with their respective school heads, are enjoined to attend the **online orientation on the implementation and execution of the VIA Playbook**, scheduled on **June 3, 2025 (Tuesday) at 1:30 p.m.** via Google Meet.
