 - In observance of the 37th National Disaster Resilience Month (NDRM) 2025 with the theme "KUMIKILOS para sa Kahandaan, Kaligtasan at Katatagan", the Schools Division Office of Dipolog City hereby invites all SDO and Field Personnel to participate in the "LINIS KALIKASAN, LIGTAS PAMAYANAN" - Miputak Creek Environmental Restoration and Community Resilience Initiative on July 26, 2025 (Saturday), 5:30 AM onwards at Miputak Creek, New SDO Building, Sta. Isabel, Dipolog City.

I. RATIONALE

In observance of the National Disaster Resilience Month and in compliance with RA 10121, otherwise known as the "Philippine Disaster Risk Reduction and Management Act of 2010," the Schools Division Office of Dipolog City recognizes the critical importance of environmental protection and disaster risk reduction through proactive community engagement.

The Miputak Creek, located near the New SDO Building in Sta. Isabel, Dipolog City, serves as a vital waterway that requires immediate attention to prevent environmental degradation and potential flooding hazards. Accumulated solid waste, debris, and other pollutants in the creek pose significant risks to the surrounding communities and may contribute to water-related disasters during extreme weather events.

This clean-up drive aligns with the DRRM framework's emphasis on disaster preparedness and mitigation, as maintaining clean waterways is essential for reducing flood risks and preserving the natural environment. The activity also demonstrates the Division's commitment to environmental stewardship and community service, setting an example for our learners and the broader community.



As part of the ongoing National Disaster Resilience Month celebration, this initiative underscores the importance of collective action in building resilient communities. By engaging SDO personnel and field personnel and personnel in neighboring government instrumentalities and establishments in this voluntary environmental activity, we foster a culture of environmental responsibility and disaster preparedness that extends beyond our educational institutions.

II. OBJECTIVES

At the end of the activity, participants are expected to:

- 1. Demonstrate environmental responsibility through active participation in creek rehabilitation
- 2. Contribute to disaster risk reduction by clearing waterways of debris and pollutants
- 3. Promote awareness on the importance of maintaining clean waterways for flood mitigation
- 4. Strengthen camaraderie among SDO personnel and field personnel through community service
- 5. Set a positive example for students and the community regarding environmental stewardship
- 6. Partner with relevant agencies in the promotion of environmental protection such as, but not limited to, Sta. Isabel and Miputak BLGUs, DILG, DSWD, DAR, DTI, PCA, Dipolog IBT Management, Philippine National Police – Dipolog Police Station, City Environment and Natural Resources Office (CENRO), City Disaster Risk Reduction and Management Office (CDRRMO), City General Services Office (CGSO), 92nd Regional Community Defense Group, Reserve Command, Philippine Army, Philippine Coast Guard Auxiliary (315th Squadron), and NGOs such as Rotary Club of Dipolog, Girl Scouts of the Philippines – Zamboanga del Norte Chapter, Boy Scouts of the Philippines – Zamboanga del Norte Chapter, Kaakibat Civicom, Dipolog City Eagles Club International and Dipolog Aqua Divers Association among others.

III. SCOPE OF ACTIVITIES

A. Pre-Activity Preparation

- Dispatch invitation letter to invited agencies, NGOs and business establishments
- Coordinate with SGOD-SMN for funding source/prospect sponsors for snacks and other necessary items
- Site assessment and safety briefing
- · Assignment of teams to different sites for clean up
- Distribution of safety equipment and cleaning materials
- Registration and grouping of volunteers
- Coordination with local barangay officials and environmental agencies

B. Main Activity

- Systematic cleaning of Miputak Creek banks and waterway
- Removal of solid waste, debris, and pollutants



- · Proper segregation and disposal of collected materials
- Documentation of the clean-up process

C. Post-Activity

- Proper disposal of collected waste materials
- Site inspection and evaluation
- Recognition of volunteers
- Documentation and reporting

IV. PARTICIPANT REQUIREMENTS

All participants are required to bring the following cleaning materials:

Personal Protective Equipment (PPE)

- Work gloves (rubber or thick cloth)
- Face masks
- Safety boots or closed shoes
- Hat or cap for sun protection
- Long-sleeved shirt or protective clothing

Cleaning Materials and Tools

- Garbage bags (large and medium-sized)
- Rakes or cleaning tools
- Brooms
- Shovels and bolo (if available)
- Containers for waste segregation
- Personal water bottle
- Towels

Optional Items

- First aid supplies
- Insect repellent
- Sunscreen
- Camera for documentation
