

STRENGTHENING CAMPUS AND COMMUNITY CLEAN-UP ACTIVITIES WITH THE LEARNER GOVERNMENT AND THE YOUTH FOR ENVIRONMENT IN SCHOOLS ORGANIZATION

- In reference to the letter dated July 25, 2025 from City Mayor Roberto Y. Uy
 regarding the promotion of a clean and healthy environment, this Division
 respectfully acknowledges the shared responsibility of maintaining environmental
 cleanliness and sustainability within school premises and surrounding areas.
- 2. Relative to this, all public schools under this Division are hereby directed to strengthen and regularly conduct clean-up activities within their respective campuses and surrounding areas with the active participation and leadership of the Learner Government and the Youth for Environment in Schools Organization (YES-O) as part of our collective commitment to environmental preservation and community responsibility.
- 3. With this, the guidelines and implementation procedures are as follows:
 - **Schedule:** Clean-up drives shall be conducted regularly on designated days as determined by each school, preferably during Brigada Eskwela activities and monthly environmental awareness programs
 - Coverage: Clean-up activities shall encompass school grounds, nearby public spaces such as sidewalks, canals, and other communal areas where waste may accumulate
 - Participants: All teaching and non-teaching personnel, students, and volunteer parents/community members shall actively participate in the cleanup activities. The Learner Government shall serve as the primary student

coordinators in all schools. For schools with established Youth for Environment in Schools Organization (YES-O), this organization shall lead the environmental advocacy and education components in coordination with the Learner Government.

- Safety Measures: Proper safety protocols shall be strictly observed during clean-up activities, including the use of appropriate protective equipment and tools.
- Mandatory Waste Segregation and Proper Disposal (while following DepEd's Ecological Solid Waste Management Act and National Greening Program guidelines):
 - o **Biodegradable Waste:** Includes food scraps, leaves, and paper. Must be placed in labeled biodegradable bins for composting, supporting the *Gulayan sa Paaralan* program.
 - Non-Biodegradable Waste: Includes plastics, metals, glass, and styrofoam. Must be segregated into appropriate bins. Burning of solid waste is strictly prohibited
 - Recyclable Materials: Includes clean paper, plastic bottles, and aluminum cans. Must be separated for reuse and recycling to promote resource conservation
 - Hazardous Waste: Includes batteries, chemicals, and medical waste.
 Must be placed in marked containers and disposed of through authorized channels.
 - Special Waste Categories: Includes e-waste and bulky items. Must be coordinated with local waste management authorities.

Schools are encouraged to practice composting, recycling, and upcycling to reduce environmental impact. All personnel and students must comply with segregation protocols using clearly labeled bins.

- 4. Additionally, schools shall integrate waste segregation education into their environmental programs and daily routines, with the Youth for Environment in Schools Organization (YES-O) taking the lead role in organizing and implementing specialized environmental campaigns. The Supreme Elementary Learner Government (SELG) or Supreme Secondary Learner Government (SSLG) shall provide active support to YES-O in these initiatives.
 - Clear signage for labeled containers shall be installed throughout school premises under the guidance of YES-O, with SELG/SSLG assisting in implementation.
 - Regular monitoring and evaluation of waste segregation practices shall be conducted by YES-O, with SELG/SSLG providing logistical and operational support. YES-O members will serve as waste segregation monitors and environmental stewards.
- 5. Moreover, school heads shall actively coordinate with barangay officials, community leaders, and local waste management facilities to ensure maximum participation and support for this environmental initiative, including proper disposal pathways for segregated waste. YES-O shall act as the primary liaison between the school

- administration and community stakeholders, with SELG/SSLG extending supplementary support where necessary.
- 6. Furthermore, schools shall properly document clean-up activities and waste segregation practices through photographs and systematically submit quarterly reports to the Division Office for monitoring purposes. The YES-O shall be responsible for documentation and basic reporting, while the Learner Government shall be responsible for printing the reports. Reports shall comprehensively include:
 - Types of waste collected and properly segregated
 - Number of participants in clean-up activities, specifically highlighting Learner Government involvement and YES-O participation where applicable
 - Educational activities and campaigns conducted on waste management (led by Learner Government or YES-O where available)
 - Community partnerships established through Learner Government coordination
 - Environmental impact assessments (where YES-O is available to conduct such assessments)
 - · Ecobricking initiatives, if any
- 7. Everybody is enjoined to actively participate in this environmental advocacy as faithful stewards of God's creation, fostering environmental awareness, waste reduction consciousness, and proper disposal discipline among students. The Learner Government shall serve as the primary model of environmental leadership and youth empowerment in all schools, with YES-O providing additional specialized environmental advocacy where the organization exists.
