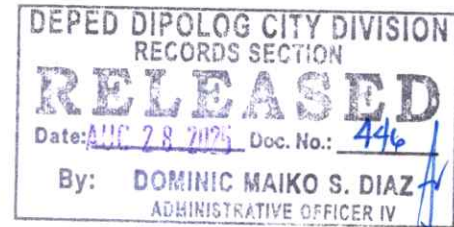

**EXPANSION AND PREPARATORY ACTIVITIES FOR THE IMPLEMENTATION OF THE  
EDUCATION FOR PROTECTION AND WELL-BEING (EPW) PROGRAM**

1. Premised on the remarkable results of the implementation of Education for Protection and Well-being (EPW), the program will be expanded this year in collaboration with SEAMEO INNOTECH to cover the following schools:

  - b. Barra Elementary School
  - c. Miputak East Elementary School
  - d. Galas Elementary School
  - e. Upper Dicayas Integrated School
  - f. Dipolog Pilot Demonstration School

  - a. School Profile – Socio-demographic, geographic description, and socio-economic status of the community where the school is located.
  - b. Learner Population – Number of enrolled learners per grade level and section.
  - c. Teacher Information – List of teachers and grade level taught, including subject teachers.
  - d. Mentor Recommendations – Names of three (3) recommended mentors from the school who will undergo training on EPW and ExSELeT modules. These mentors will also conduct roll-out training sessions for teachers and provide ongoing support for integration.

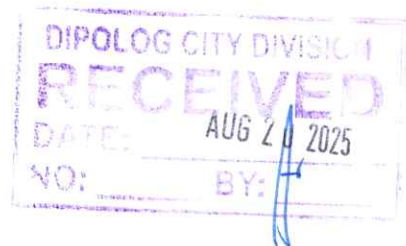


As we begin the preparatory phase for the implementation of the **Education for Protection and Well-being (EPW)** program in selected target schools with integration of modules developed in collaboration with SEAMEO INNOTECH on *Exemplifying Social and Emotional Learning in Children's Environment and Teachers' Pedagogy (ExSELeNT)* and Child Protection.

The initial step involves gathering relevant data from your school, which will serve as the basis for setting targets and planning subsequent activities and schedules. These will be determined in accordance with the number of identified teachers and learners. A consultation meeting will be scheduled to present the implementation plans and to finalize workable timelines in coordination with the Schools Division Office (SDO). These activities are expected to commence within the current school year for these schools, Sta. Cruz Elementary School, Barra Elementary School, Miputak East Elementary School, Galas Elementary School, Upper Dicapayas IS and Dipolog Pilot Demonstration School.

In line with this, may we kindly request these schools to submit the following information. This will form part of the baseline information and reference to plot the target for the program. You may use the suggested template attached. Would appreciate receiving the information on or before September 15, 2025.

1. **School Profile:** Including the socio-demographic, geographic description and socio-economic status of the community where the school is located.
2. **Learner Population:** Enrolled learners per grade level and section
3. **Teacher Information:** List of teachers and grade level taught, including subject teachers
4. **Mentor Recommendations:** Names of three (3) recommended mentors from the school who will be trained on the EPW and ExSELeNT modules during the last quarter of the year. The selected mentors will be responsible for conducting rollout training sessions for their fellow teachers. They will also provide ongoing support for the integration of the EPW and ExSELeNT sessions across various subject areas, with technical guidance from the SDO and the ChildFund training team.
