

- 1. In reference to the DepEd Order No. 5, s. 2014 entitled "Implementing Guidelines on the Integration of Gulayan sa Paaralan, Solid Waste Management and Tree Planting Under the National Greening Program" and Division Memorandum No. 438 s. 2025 entitled "Recognizing Aces and Champions Of Excellence (Race) Awarding Ceremony Cum National Teachers Month and Philippine Civil Service Anniversary Celebration", the Dipolog City Schools Division, through the Disaster Risk Reduction and Management Service, announces the conduct of a Tree Planting and Tree-Growing Activity on September 13, 2025 (Saturday) that aims to promote environmental stewardship among our personnel, symbolize our commitment to nurturing future generations, and contribute to the beautification and resilience of our school communities.
- 2. Accordingly, this division-led activity shall be participated in by all DepEd personnel from the Schools Division Office and all public schools. For this purpose, the clustered districts (North A, North B, etc.), under the supervision of their respective Public Schools District Supervisors (PSDSs), shall simultaneously implement the activity in ten (10) designated school premises or other identified areas. In cases where DepEd-adopted spaces are not available, coordination with the respective Barangay Local Government Units (BLGUs) shall be undertaken to identify appropriate sites.
- 3. Furthermore, the DRRMS Office shall be assigned for the provision of seedling materials to be used during the activity in coordination with the Offices of the Provincial Agriculturist and City Agriculturist. For activities within school grounds, fruit-bearing trees/seedlings or vegetable seedlings should be prioritized to support school-based food production and nutrition programs. For activities outside school premises,

hardwood trees shall be planted to contribute to reforestation and environmental conservation efforts. Date and venue of distribution of these seedlings will be announced accordingly.

- Moreover, participants are entitled to Compensatory Overtime Credits (COC) or Vacation Service Credits (VSC), whichever is applicable, subject to existing guidelines and policies.
- 5. In addition, participants are advised to wear appropriate attire, safety equipment and planting materials (trowel, shovel, gloves), and their own drinking water during the event.
