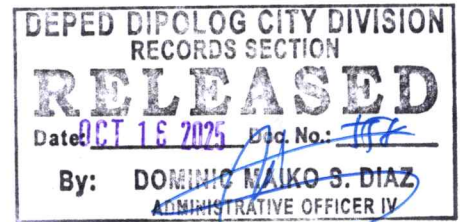

1. Pursuant to DepEd Memorandum No. 96, s. 2025, titled "**Learners' Convergence Philippines 2025**," which stipulates that the Convergence shall be held from **October 27-30, 2025**, in **Dumaguete City, Negros Oriental**, this Division issues this Memorandum to announce the official participants, logistical arrangements, and other pertinent details regarding participation in this national event.
2. The Learners' Convergence Philippines (**LearnCon PH**) is the largest face-to-face gathering of learners, youth leaders, and education stakeholders nationwide. It provides a meaningful platform for participants to enrich their learning experiences, embrace cultural diversity, and strengthen their leadership skills in pursuit of excellence and nation-building.
3. As stipulated in the administrative guidelines, **nine (9) learners and three (3) chaperones** shall represent this Division in the said event. The list of official participants is attached as **Enclosure No. 1**.
4. Designated chaperones are directed to coordinate with the Regional and Central Offices for the submission and approval of all required documents. They shall also facilitate the pre-registration of all participants in accordance with the prescribed process.
5. In compliance with the national directive, the travel and incidental expenses of learner-participants and chaperones shall be charged to the LSP/PSF 2025 funds, Local Funds, MOOE, Local School Board – SEF, or other available funding sources, subject to existing accounting and auditing rules and regulations.

6. Accommodation and meals shall be provided free of charge by the Central Office. Participants from Region IX will be billeted at South City Elementary School, Dumaguete City, Negros Oriental, from 1:00 p.m. of October 26 (Sunday) to 12:00 p.m. of October 31 (Friday). The first meal will be lunch on October 26, and the last meal will be breakfast on October 31.

7. All identified student-participants and chaperones are required to attend an **Orientation and Photoshoot** on **October 17, 2025** (Friday), at **1:00 p.m.**, at the **Technical Assistance Room (3rd Floor)**, Schools Division Office of Dipolog City, Government Center, Sta. Isabel. Participants are advised to:

- Wear their school uniform and bring their school ID;
- Accomplish the Parent's Consent and Waiver Form and Learner's Consent and Waiver Form; and
- Submit the accomplished forms during the Orientation.
