Guidelines on the Conduct of Partnership Excellence Awards: A PRAISE for Stakeholders

1.0 Rationale

The Department of Education (DepEd) recognizes the importance of celebrating and rewarding the contributions of employees through the Program on Awards and Incentives for Service Excellence (PRAISE), as mandated in DepEd Order No. 9, s. 2022. In line with this initiative, the RACE committee proposes expanding its scope to honor not only employees but also learners and stakeholders who significantly contribute to educational efforts and initiatives.

While the annual Stakeholders Summit acknowledges the support of private individuals, establishments, and groups through the Building Partnerships and Linkages Program, expanding RACE takes recognition to the next level. By incorporating learners and external stakeholders into RACE, we aim to honor and value their contributions more comprehensively. This broader recognition is vital in fostering a culture of appreciation and encouraging continued support and engagement from the entire educational community.

This expansion aligns with the spirit of Republic Act 8525, or “The Adopt a School Act of 1998,” which established the Adopt-a-School Program (ASP). The ASP serves as a foundation for the proposed **Partnership Excellence Awards**, designed to acknowledge stakeholders whose noble goal is the education of all Filipinos. By integrating these awards into RACE, we underscore the importance of collaborative efforts in education and highlight the critical role stakeholders play in addressing the resource needs of public schools and enriching the community through education.

Excellence awards are recognition programs designed to acknowledge and celebrate individuals or organizations with exceptional performance, achievements, or contributions in the field of education.

2.0 Specific Objectives

- To recognize and encourage Stakeholder Initiatives by highlighting success stories of impactful stakeholder partnerships to serve as models of excellence and inspire others.
- To strengthen and foster educational partnerships by actively seeking and engaging new stakeholders, promoting the benefits of collaboration in education initiatives, and demonstrating the positive outcomes of partnerships.

3.0 Scope

The guidelines will cover all stakeholders who assisted public schools within the division. Eligible stakeholders must meet the following criteria:

- *Scope of Support* – Stakeholders who extend assistance to one or multiple schools or contribute at the division level.
- *Donations or Services Offered* – Stakeholders who provides financial aid, materials, infrastructure, training, scholarships, or other educational support.
- *Impact of Support* – Contributions made by the Stakeholders create measurable improvements in education, benefiting students, teachers, or school facilities.
- *Credible Track Record* – Stakeholders demonstrate sustained and meaningful contributions to public schools with a history of positive impact.
- *Legal Registration or Accreditation* – Stakeholders may be a legally recognized entity registered with SEC, CDA, or other relevant accreditation bodies.
- *Ethical Standards* – Stakeholders upholds integrity, promotes a safe learning environment, and is not involved in any illegal activities.

By adhering to these criteria, the Partnership Excellence Awards will recognize and celebrate stakeholders who demonstrate genuine commitment in enhancing the quality of education and well-being of learners in public schools.

4.0 Definition of Terms

Terminologies are defined to better understand this guideline:

- a. *5-point Agenda* is a strategic plan of the Department, which ensures: (1) an enabling learning environment; (2) the welfare of teachers; (3) the well-being of learners; (4) efficient learning delivery in all its forms; and (5) a future-ready workforce.
- b. *Adopt-a-School Program* refers to a mechanism that allows private entities to assist public schools in particular aspects of educational programs within an agreed period
- c. *Agreement* refers to a Memorandum of Agreement entered by and between the private entity and the public school or the division specifying the terms and conditions of the adoption, including tasks and responsibilities of the contracting parties.
- d. *Annual Improve Plan or AIP* refers to a roadmap that lays down specific interventions that a school, with the help of the community and other stakeholders.
- e. *Assistance* refers to the help/ aid/ contribution/ donation provided by an adopting entity to a public school. Assistance may be in the forms of infrastructure, teaching and skills development, learning support, computer and science laboratories, food and nutrition, service and others.
- f. *Community Learning Center or CLC* refers to a local place of learning outside the formal education system. Located in both villages and urban areas, it is usually set up and managed by an Alternative Learning System to provide various learning opportunities for community development and improvement of the quality of life.

- g. *DepEd Partnerships Database System or DPDS* refers to an internet-based portal that is designed to unify assistance programs and aid from the private and public sectors
- h. *External stakeholders* are individuals, organizations, or groups outside the school system that contribute to and influence education through support, resources, or partnerships. (ie Government Agency, NGO, Private and Business Sector, Alumni Association and others)
- i. *MATATAG* is an update to the Philippine education system that aims to improve things. It stands for (1) Make the curriculum relevant to produce competent, job-ready, active, and responsible citizens; (2) Take steps to accelerate the delivery of basic education facilities and services; (3) Take good care of learners by promoting learner well-being, inclusive education, and a positive learning environment; and (4) Give support to teachers to teach better.
- j. *Partnership Excellence Awards Committee or Committee* refers to a group of people from other sectors/ offices that is assigned to receive, assess/ evaluate, and award the nominated individuals or groups.
- k. *PPAs* generally refer to the Department's programs, projects, and activities
- l. *Project Proposal* refers to a written document outlining everything stakeholders should know about a project that is aligned to SIP or AIP.
- m. *Public School* refers to a government school whether elementary or secondary which enters into an Agreement with the private entity concerning assistance herein referred to.
- n. *RACE* means Recognition of Aces and Champions of Excellence
- o. *School Improvement Plan or SIP* refers to a plan that aims to monitor progress, evaluate outcomes, and ensure the school's strategic plans and operations align with its vision and support improved teaching, learning, and performance.

6.0 Records and Documents

Documents must be prepared by the schools:

- Copy of Signed Memorandum of Agreement/ Understanding and/or Deed of Donation/ Acceptance or Statement of Interest Form
- Uploaded in the DPDS
- Approved Project Proposals
- Accomplishment Reports with Photo or Video Documentation
- School Improvement Plan/ Annual Implementation Plan

7.0 General Provisions

7.1. This guideline shall be adhered to in the awarding process under the Rewards and Recognition System of the Dipolog City Schools Division RACE, in coordination with Social Mobilization and Networking Section.

7.2. Any Committee member who accepts a nomination or is related to a nominee must abstain from participating in the proceedings before the evaluation and selection date of the current year.

7.3. This guideline shall apply to the recognition of both major and minor stakeholders, as determined by the RACE Committee. Awards will be categorized based on the programs, projects, and services supported either at the school or division level, provided these are aligned with the Department's vision.

Stakeholders may be recommended for division-level awards depending on the extent and impact of their support, subject to the evaluation and final decision of the committee.

8.0 Nomination System

Nominations shall be endorsed and facilitated by the school head, school partnership focal persons, program proponents, and other stakeholders (Parent-Teachers Association, Local School Board, National Employees Union), based on the following indicators:

- **Extent of Support and Contribution**
This criterion assesses the quantity and quality of assistance provided by the stakeholder. It includes financial donations, educational materials, infrastructure projects, and services that directly benefit students, teachers, or school operations.
- **Sustainability and Long-Term Impact**
This evaluates whether the stakeholder's support extends beyond a one-time donation. Sustainable programs include initiatives that have lasting effects, such as scholarship programs, teacher training, livelihood assistance for school communities, or infrastructure projects with proper maintenance and support.
- **Alignment with Educational Goals**
Contributions should align with the division's and DepEd's strategic priorities, such as improving literacy, numeracy, digital learning, teacher development, and student well-being. Assistance provided should support national programs like the MATATAG or 5-point Agenda, Brigada Eskwela, and the Adopt-a-School Program.

- **Reach and Scope of Assistance**

This criterion measures how many schools, teachers, or students benefited from the stakeholder's contributions. It recognizes stakeholders who provide support to multiple schools or prioritize the most disadvantaged communities, ensuring inclusivity and equity in education.

- **Commitment and Consistency**

Long-term commitment to education is key. This criterion evaluates how often the stakeholder has provided assistance, whether their engagement is sustained over the years, and if they continue to support education initiatives beyond a single event or project.

The Social Mobilization and Networking (SMN) Section personnel may also nominate or endorse stakeholders based on recorded donations in the DepEd Partnerships and Database System, as well as their support for division-level advocacy activities. Additionally, they are responsible for consolidating the list of nominated stakeholders and tracking the number of times each stakeholder has been nominated. After this process, schools may proceed with preparing and submitting the necessary documents for evaluation.

The Division RACE Committee may also endorse and recognize deserving stakeholders, to strengthen and sustain their commitment to supporting education. Following this, schools again may proceed with processing and submitting the necessary documents for evaluation.

The committee may also grant awards to school heads, program coordinators, and other key individuals in recognition of their contributions and dedication to educational initiatives.

9.0 Evaluation of Nominees

To ensure a thorough evaluation, schools, CLCs, and other stakeholders, must nominate and submit the following required documents for the awards. Once submitted, portfolios will become the property of the committee. The necessary documents and records include:

- Accomplished Nomination Form
- Stakeholder Profile
- Approved Proposals by the Stakeholder
- Signed MOA/MOU and/or DOD/DOA or Statement of Interest Form
- PPAs Accomplishment Report
- Photo or Video Documentation

If a stakeholder is nominated multiple times, all submitted documents will be consolidated into a single entity. The scoring will be based on the total number of documents submitted, ensuring that the overall impact and scope of the stakeholder's contributions are properly assessed.

All documents must be submitted at the division level, where they will be evaluated by the Division RACE Committee. The covered period of reports/ documentation is based on a calendar year (January to December).

Submission of Documents	November or December
Evaluation of Documents	November or December
Awarding Ceremony	December or January

Documents are essential to ensure that donations received by schools from stakeholders are uploaded into the system and are properly documented.

10.0 Work Plan

The committee shall establish and communicate the schedule for screening and evaluation, as approved by the Division RACE, every December to January. The work plan will also be published through a memorandum detailing the mechanisms for implementing activities and events, including the Awarding Ceremony.

11.0 Funding

The committee will offer non-monetary awards to honor and appreciate innovative and supportive stakeholders who have significantly contributed to the well-being of learners and the community. The fund source for these awards will be charged from division MOOE or any other fund source.

12.0 Criteria for Award Categories

Recognizing partnership excellence in the community involves setting clear and specific criteria to identify individuals or organizations that have made significant contributions to education. The following criteria shall be used in the evaluation and selection process:

- Extent of Support and Contribution
Categorized Implemented Programs, Projects, and Activities (PPAs)
Support should be assessed as either a major or minor activity.

Amount Donated

The total amount donated, whether monetary or in voluntary services, should be reflected in the DepEd Partnerships Database System (DPDS).

- Sustainability and Long-Term Impact

Documentation of Assistance/Donations

Required documents include a signed Memorandum of Agreement (MOA), Memorandum of Understanding (MOU), Deed of Donation (DOD), Deed of Acceptance (DOA), or a Statement of Interest Form

Impact of PPAs on Beneficiaries

The positive effects of the support provided should be assessed through written or verbal feedback/ testimonials.

- Alignment with Educational Goals

Granted Project Proposal

Funded proposals must align with the school's or division's strategic plan.

Supported DepEd Initiatives (MATATAG or 5-point Agenda)

Assistance should correlate with the components of the DepEd (MATATAG or 5-point) Agenda.

- Reach and Scope of Assistance

Number of Beneficiaries Reached

The scope of provisions should be detailed at both school and division

- Commitment and Consistency

Bonus points will be given if the stakeholder provided assistance in the previous calendar year, ensuring consistency in their support for education.
