




I. Introduction

The Philippines is one of the countries most at risk of natural disasters, especially floods and landslides. These hazards have become stronger and more unpredictable because of climate change. Heavy rains during the rainy season (June to December) often cause flash floods and landslides that endanger lives, damage homes and roads, and disrupt schools and communities across the country.

In Mindanao, Zamboanga Peninsula Region (Region IX) is geographically characterized by hilly to mountainous terrain, major river systems, and coastal lowlands, conditions that make it highly susceptible to landslides and flooding, especially during the southwest monsoon, tropical cyclones, Intertropical Convergence Zone (ITCZ) activities, and occasional typhoons or low-pressure areas. Provinces such as Zamboanga del Norte, Zamboanga del Sur, and Zamboanga Sibugay, along with the cities of Zamboanga, Dipolog, and Isabela, have experienced recurring incidents of flooding and landslide triggered by continuous heavy rainfall, resulting in property damage, displacement of families, and even loss of lives.

Climate change has intensified rainfall further patterns. increasing the frequency and severity of The flooding to schools. occurrence of landslides in upland areas and flash floods low-lying communities highlights the urgent need to local strengthen disaster preparedness, risk mitigation, and adaptive capacity.

Source: Multi Hazard Risk Profile of Schools Multi Hazard Risk Profile of Schools



















Below are the images of Multi-Hazard Risk Profile of DepEd Schools withing Zamboanga Peninsula.

In line with the objectives of RA 10121 (Philippine DRRM Act of 2010) and the DRRM Framework of Department of Education, this initiative seeks to enhance the resilience of communities, schools, and local institutions in the Zamboanga Peninsula through proactive landslide and flood risk management.

The Regional Climate Change Caravan is a timely and relevant initiative that aims to promote climate change awareness, education, and action among the communities of the Zamboanga Peninsula. It embodies a collaborative effort that unites communities, educational institutions, local government units, and various sectors to strengthen collective responsibility and foster a unified regional movement toward climate resilience and sustainable development.

II. Objectives

This activity aims to develop strategic actions and adaptation initiatives to help minimize the potential effects of flooding and heavy rainfall on learners, personnel, schools, and the wider community.

Prioritizing ecological and environmental stability, not only in Dipolog City but throughout the entire Zamboanga Peninsula is critical to mitigating risks in a region that is increasingly vulnerable to extreme rainfall events due to its geographic and socio-economic characteristics. Although the most severe impacts may not yet be fully apparent, proactive measures are essential. Through the initiatives of the Regional Climate Change Caravan, schools and local stakeholders will be better equipped to confront these challenges and advance toward a more climate-resilient and secure future.

III. Expected Outputs

- 1. Increased awareness and understanding of climate change impacts on education
- 2. Enhanced capacity of division and school-level DRRM coordinators
- 3. Documented best practices and innovative DRRM-CCA initiatives from ZAMPEN divisions
- 4. Signed commitments from participating divisions for climate change initiatives
- 5. Distribution of 220 seedlings to promote environmental stewardship
- 6. Strengthened multi-sectoral collaboration and partnerships to support climate change adaptation and mitigation initiatives in schools.






