

In anticipation of the National Science and Technology Fair (NSTF) tentatively scheduled for March 9 – 13, 2026, the Scientific Review Committee (SRC) meeting in December 9 and 10, 2025 and Regional Coordinators Meeting in December 11 and 12, 2025, this Office advises all Regional Offices to conduct their respective Regional Science and Technology Fairs (RSTF) on or before November 30, 2025.
