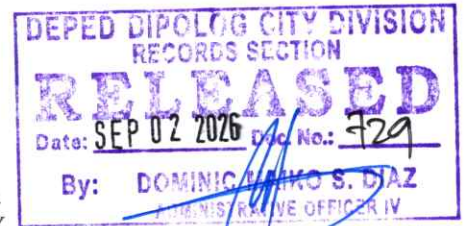

**DIVISIONWIDE ORIENTATION ON THE SEARCH FOR THE 2026 MOST

1. Pursuant to the annual PRAISE for Learners' Search for the Most Outstanding SSLG President, this Division, through the Learner Formation Unit, shall conduct the **Divisionwide Orientation on the Search for the 2026 Most Outstanding SSLG President on September 5, 2026 (Saturday), at 8:00 a.m. at the 3/F TA Room, DepEd SDO Dipolog Building, Government Compound, Sta. Isabel, Dipolog City.** The activity shall orient and prepare the SSLG Presidents of the 17 public secondary schools for the different phases, requirements, expectations, and assessment components of this year's search. The activity shall also serve as a Special Meeting of the DepEd Dipolog Division Federation of Supreme Secondary Learner Government (DFSSLG) to discuss matters concerning the federation and its member organizations.

2. Specifically, the orientation aims to:

- provide SSLG Presidents with a comprehensive understanding of the objectives, mechanics, criteria, requirements, and timeline of the Search for the 2026 Most Outstanding SSLG President;
- capacitate SSLG Presidents with the necessary knowledge and preparation to effectively participate in the different phases of the search; and
- clarify the roles, responsibilities, and expectations of the participating SSLG Presidents and their Teacher-Advisers throughout the search process.

3. The DFSSLG Special Meeting shall likewise take up the following agenda:

- Monitoring of Ongoing and/or Implemented SSLG-Led School-Based Programs, Projects, and Activities (PPAs);
- Distribution of the DFSSLG Batch Torchbearers Uniform; and

4. All 17 SSLG Presidents are enjoined to attend this activity. See **Enclosure 1** for the complete list of participants.

5. All School Principals and SSLG Teacher-Advisers shall coordinate with their respective SSLG Presidents and facilitate the necessary arrangements for their attendance at the venue.

6. Snacks and lunch shall be provided to all SSLG Presidents.

7. Transportation expenses to and from the venue may be charged against the School MOOE, PTA-VSC Funds, or other available funds intended for youth programs, subject to existing accounting and auditing rules and regulations.

8. Non-teaching personnel who attend the activity shall be granted 1.50 Compensatory Overtime Credits (COCs) for an eight-hour activity, subject to existing policies and guidelines.

9. SSLG Teacher-Advisers shall secure the parental consent forms of their respective SSLG Presidents and submit them to the Division Learner Formation Coordinators (DLFCs) on or before the day of the activity. See **Annex A** for the prescribed template.
